Self- Lay Providers (SLP)

We consider there will be insignificant impact on the SLP's with the changes in rates between 2020/21 to 2021/22. However, in 2021/22 Southern Water will no longer be offering a design service for S51 applications. SLP's will be required to undertake the design themselves in accordance with the Design and Construction with the introduction of the Design and Construction Specification (DCS) document. The 2021/22 charges have been amended to reflect this change in working. The current and new charges are detailed below. More information is available in the 2021/22 Charging Arrangement document.

Bill increases of over 10%

There are no scenarios where costs increase by more than 10% between 2020/21 and 2021/22 charges. There are savings on all Scenarios ranging from 8.1% to 22.8%. The key driver for the savings is a reduction in the Wastewater Net charge whilst other charges remain unchanged or there are minimal increases. Below is a summary of the changes in the charges from 2020/21 to 2021/22.
