1 Background

Southern Water is applying for a Drought Order under Section 79A the Water Resources Act (WRA) 1991 to make temporary amendments to abstraction licence 11/42/18.16/546 to abstract water from the River Test.

Southern Water is also applying for a Drought Order to restrict non-essential uses of water under sections 73 and 74(2)(b) of the Water Resources Act 1991.
